MOT PROMOTIONAL OFFER - TERMS AND CONDITIONS

1. The Promoter

2. The promotion

- 2.1 Between 1st January 2025 31st March 2025 inclusive, the Promoter will be offering eligible customers a free MOT of their Vehicle at one of its Eligible Retailers, subject to these terms and conditions.
- 2.2 An MOT is a roadworthy test that is required by the DVSA for most vehicles within the UK. For further details see the DVSA website.

3. How to claim

- 3.1 This promotion will run from 1st January 2025 to 31 March 2025 inclusive ("the Promotion Period").
- 3.2 To be eligible, you must privately own a UK registered Toyota passenger car (the "Vehicle") during the Promotion Period.
- 3.3 The MOT must be carried out upon the Vehicle within the Promotion Period at one of the Eligible Retailers.

3.5 To participate:

- (a) You must book your MOT slot for your Vehicle with an Eligible Retailer, through the following methods:
 - (i) By telephone to one of the Eligible Retailers.

- (ii) Via an online booking form with an Eligible Retailer. You will either be able to book a slot directly through this form or a representative from the Eligible Retailer will contact you directly to arrange a suitable slot.
- (iii) Walk-in to an Eligible Retailer.

Slots are limited to 10 per day per Eligible Retailer so booking in advance is required.

- (b) Once you have booked your MOT, then you must bring your Vehicle to the Eligible Retailer site in accordance with your confirmation details unless alternative arrangements have been agreed with your Eligible Retailer at the time of booking.
- (c) The Eligible Retailer will then liaise with you directly in relation to your MOT and handover of the Vehicle upon their own terms and conditions.
- 3.6 The MOT will be carried out by an MOT trained technician to the industry standard. Additional charges will apply for any further work or repairs..
- 3.7 In the event that you fail to show for your pre-booked appointment, rescheduling will be at the discretion of the Eligible Retailer and subject to availability.
- 3.8 By participating, you are agreeing to be bound by these terms and conditions.

4. Eligibility

- 4.1 Subject to any other provisions of these terms and conditions this promotion is available to customers aged 18 or over, who privately own a UK registered Toyota car. Fleet customers and large commercial vehicles are excluded.
